Purpose and description of the content of education		<p>The task of the public economic law module is for students to acquire knowledge, skills and competence in the field of issues related to the legal regulation of undertaking and conducting business activity, the rights and obligations of entrepreneurs in undertaking and conducting business activity, the basic measures of rationing business activity in Poland, as well as competition law and the principles of conducting business activity in selected economic sectors, and the basic principles of functioning of the internal market of the European Union and their impact on the regulation of undertaking and conducting business activity in Poland.</p> <p>Legal to counteract agreements The task of the subject of public economic law is for students to obtain knowledge, skills and competencies in the field of issues related to the legal regulation of undertaking and conducting business activity, rights and obligations of entrepreneurs in the field of undertaking and conducting business activity, basic means of rationing measures of economic activity in Poland, as well as the law of competition and rules of doing business The law of competition and the principles of doing business in selected business sectors The law of competition and the rules of conducting business activity in selected sectors of the economy, as well as the basic principles of the functioning of the internal market of the European Union and their impact on the regulation of undertaking and conducting business activity in Poland. - The goal of the course is for students to acquire knowledge, skills and competence in the field of issues related to the legal regulation of undertaking and conducting business activity, the rights and obligations of entrepreneurs in undertaking and conducting business activity, the basic means of rationing business activity in Poland, as well as competition law and the principles of conducting business activity in selected economic sectors and the basic principles of functioning of the internal market of the European Union and their influence on the regulation of undertaking and conducting business activity in Poland.</p> <p>During the course of the course the student is introduced to the basic information on Polish and European public economic law, and in particular on :</p> <ul style="list-style-type: none"> <li>- issues related to undertaking and conducting business activity by domestic entrepreneurs and by foreign entrepreneurs from both EU member states and from outside this area.</li> <li>- the rules of operation of the basic registers in economic circulation - KRS and CEIDG</li> <li>- rights and obligations of entrepreneurs,</li> <li>- rationing of business activity</li> <li>- rights of foreign entrepreneurs on the Polish market and the impact of EU law, including the Directive on services in the internal market on the regulations of Polish public economic law.</li> <li>- Competition law, including activities of public administration bodies in the field of competition protection and legal regulations aimed at counteracting the conclusion of agreements limiting competition and abuse of dominant market position.</li> </ul>

a01	Lecture methods / expository methods	Formal lecture/ course-related lecture <i>a systematic course of study involving a synthetic presentation of an academic discipline; its implementation assumes a passive reception of the information provided</i>
a05	Lecture methods / expository methods	Explanation/clarification <i>explication involving the derivation of a predetermined theorem from other, already known ones, in the number of steps specified by the person teaching the course</i>
b04	Problem-solving methods	Activating method – discussion / debate <i>an exchange of views supported by substantive arguments leading to a clash of different views, a compromise or the identification of common positions; it proceeds according to previously agreed-upon rules regarding the time, manner and turn-taking as well as the principles of civil discourse; a discussion is not a competition but aims at finding the best solutions or presenting different points of view; its varieties include brainstorming, Oxford-style debate, panel discussion, decision tree, conference discussion; a debate is an orderly dispute between supporters and opponents of a viewpoint, usually specialists in the field or pre-selected representatives of a group dealing with a common problem</i>
b07	Problem-solving methods	Activating methods: a case study <i>a comprehensive description of a phenomenon connected with the selected discipline; reflecting the reality, presenting the 'what', 'where' and 'how' of the phenomenon, i.e., all of its key aspects to be discussed in class; used as a reproduction, presentation, discussion or diagnosis of factors that shape the phenomenon or interact with it; an in-depth qualitative analysis and evaluation of a selected phenomenon</i>
b08	Problem-solving methods	Activating method – peer learning <i>learning through the exchange of knowledge in a group/team/pair of students, i.e., in the so-called learning cell; a kind of mutual learning; an approach focused on student activity under the guidance of the person teaching the course; a learning situation where students with a similar level of experience learn from one another</i>
c07	Demonstration methods	Screen presentation

		<i>a presentation of synthetic image content using computer graphics, e.g., a series of slides or other multimedia forms, usually accompanied by a commentary; typical components of a screen presentation include text organized into bulleted points, charts, images and animations, sometimes sound effects or music; a multimedia illustration of course content presented in the form of a projected image</i>
d02	Programmed learning methods	Working with a programmed textbook <i>working with a textbook containing instructional material covering part of or the entire curriculum of the module as well as a formula for studying the content; includes working with a subject textbook, an atlas, a catalogue, a problem book, etc.</i>
