The aim of the course is to deepen students' understanding of the importance of non-litigious proceedings in the civil law system, with particular focus on the role of the court and participants in these cases. The module includes an analysis of provisions governing non-litigious proceedings, including procedures related to inheritance matters, personal, property, and deposit law cases. Classes will also focus on presenting doctrinal views, interpretations of legal provisions, and court rulings, enabling students to understand the practical application of the law in non-litigious proceedings.
